Message from the Hospital CEO and Volunteer Board Chair

Caring for Our Community – The Heart of Our Hospital

As we reflect on the year now passed, we are reminded of how often we engage with the community so that we can better meet their needs and provide the best health care possible. As our vision states, we truly are “A community of health, hope and compassion for all.”

Our Hospital has always provided services to a large proportion of First Nations and Métis patients. In October, St. Paul’s Hospital extended this commitment to more broadly help heal our entire shared community. Together with Saskatoon Health Region, on October 14, 2016, we raised the Truth and Reconciliation flag on the front lawn of the Hospital. This declaration provides a visible acknowledgement that we are all on Treaty Six land and is a symbolic expression of our Hospital’s deep commitment to, and acknowledgement of, the healing that is required in our community. We are committed to fostering respectful and equitable care that addresses emotional, physical, mental and spiritual healing in an environment that is welcoming to both family and the larger community.

The Mission Office continues to guide us as we deliver holistic care to all in need and further the work inspired by the Grey Nuns to serve God by connecting us to the community through programs such as Community Day and the Healing Arts Program.

The Kidney Health Community Program (KHCP) is working to prevent kidney disease by promoting healthy living to people in Saskatoon, its surrounding areas and Northern Saskatchewan. Engagement forums called “Nisohkamâtowak” (Helping Each Other) are allowing us to make a positive, healthy difference in the lives of many in the communities we serve.

Mental Health and Addiction Services is working closely with nearby partners to develop new approaches to care that are helping us build better relationships with clients, helping those who use Hospital services frequently to access support in the community, and striving to reduce the stigmas associated with mental health and addictions.

These are only a few of the initiatives you will read about in this Annual Review. They remind us that we truly are better when we work together. We continue to work closely with Saskatoon Health Region, and are grateful for this partnership that makes us a stronger Hospital. In the coming year, St. Paul’s Hospital will work to secure our place within the new provincial health system.

This year we welcomed three new members to our Hospital Board of Directors: Darryl Bazylak, Gene Dupuis and Pina Melchionna. While we were saddened to say goodbye to Bill Edwards, our Past Chair, as he completed his term on the Board, we look forward to continuing to work with our new Board in the upcoming year.

Inspired by the healing power of God, the Grey Nuns founded St. Paul's Hospital in 1907. Our Hospital is a 230-bed acute care teaching facility that provides medical services and expertise to the people of Saskatoon and Northern Saskatchewan.

The Hospital is governed by a volunteer Board of Directors on behalf of our owners, the Bishops of Saskatchewan, through Emmanuel Care. Our physicians, health care workers, staff and volunteers strive to deliver compassionate, holistic medical care that focuses on healing the body, mind, spirit and soul in an environment that is welcoming to family and community.

St. Paul's Hospital is supported through a partnership with Saskatoon Health Region. On behalf of the Health Region, St. Paul's provides expertise and leadership, and manages the following programs across the Region:

- Chronic Disease Management
- Diagnostic Imaging and Nuclear Medicine
- Emergency and Air Ambulance Services
- Ethics Services
- Kidney Health and Provincial Transplant Services
- Laboratory Medicine and Pathology Services
- Mental Health and Addiction Services
- Palliative Care and Hospice Services
- Spiritual and Cultural Care Services

While St. Paul's Hospital plays a role in all other programs and services at the Hospital, these others are managed by the Saskatoon Health

Region. St. Paul's also is home to the Leslie and Irene Dubé Urology Centre of Health, and houses several Saskatoon Health Region administrative offices.

Mission Office

Supporting Holistic and Compassionate Care

St. Paul's Hospital Mission Office provides support to staff, patients and the community to help inspire them to live the vision, mission and values of St. Marguerite d'Youville and the Grey Nuns who founded St. Paul's Hospital.

Each day the Mission Office completes daily rounds to check in on the well-being of staff. The office also publishes *The Lifeline* staff newsletter, and organizes events that recognize and support staff in their commitment to holistic and compassionate care.

Every October the Mission Office hosts Mission Week, a week-long celebration of staff, physicians and volunteers. Events include Feast Day and a Commitment Ceremony. The SPH Foundation Professional Development Awards and the Mission in Action Awards are both presented during Mission Week.

The Mission Office follows the example of the Hospital's founders, the Grey Nuns, in welcoming community and family as we work toward our vision of "A community of health, hope and compassion for all." Each year, St. Paul's Hospital brings together neighbourhood children and the surrounding community to celebrate our vision. On May 25, 2016 over 800 folks of all ages gathered on the front lawn of the Hospital to take part in our 24th Annual Community Day celebration.

The Healing Arts Program, founded by the Mission Office and Volunteer Workforce, enhances the holistic nature of the care provided at St. Paul's Hospital. The program creates opportunities for patients and families to express themselves and create meaning through visual art, music therapy and literary art. The service is brought to patients, family and community at the bedside, in common areas of the hospital and in the Healing Arts studio.

This year, Artist-in-Residence Marlessa Wesolowski and Music Therapist Carmen Formanek-Loncar were joined by Writer-in-Residence Kristine Scarrow, who is connecting with patients, their families and staff through creative writing.

Healing Arts Program works can be seen in display cases and on the walls and ceiling tiles throughout our Hospital, offering moments of reflection and relief for all who visit and work at the Hospital. We are deeply

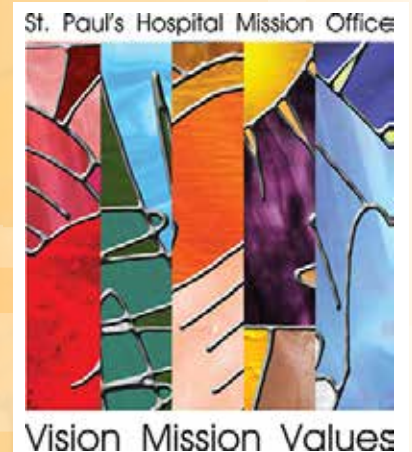
thankful to all donors who support this important program.

Spiritual and Cultural Care

Holistic care is one of St. Paul's Hospital's core values. We live this core value at St. Paul's with the help of Spiritual and Cultural Care Services, which supports us in providing holistic care to patients. Spiritual Care at St. Paul's Hospital is funded through Hospital revenues, the Grey Nuns' Legacy Endowment Fund and community donor support.

When people come to hospital either temporarily or for long-term care, they often are experiencing strong emotions stemming from fear, loss and/or grief. For many, health has declined to the extent that they can no longer care for themselves, let alone for the people they love. Their realization of self has declined and senses of meaning, identity, and purpose are eroding. Consequently, relationships with others are altered. This is the purview of the spiritual, and is the need addressed by the Spiritual Care team, who are trained by a nationally accredited body to provide holistic care in such circumstances.

Many people rely on their faith and their own faith community for this kind of support. Accordingly, we either facilitate a connection with their faith community or simply pray with them as they desire. The Hospital Chapel, Multi-faith Stillness Room, First Nations Prayer and Ceremonial Room and Quiet Rooms all provide sanctuary and sacred spaces for quiet reflection for patients and their families.

Managed Programs

Area Highlights

Ethics Services

As a Catholic facility, ethics has always been at the forefront of the care we provide. Ethics Services provides patients, families and staff with the ethical and moral support they need when dealing with health circumstances that may lead to moral distress. Ethics Services staff provide education and meet with patients, families and staff to discuss ethical decision making.

The 2016 William F. Mitchell Bioethics Seminar, held November 24, 2016, at St. Paul's Hospital, addressed the topic "Building Bridges: Supporting Health Care Workers to Be Champions of Reconciliation." The event featured University of Saskatchewan Medical Anthropologist Dr. Caroline Tait. Dr. Tait provided insight into how people have been affected by the historical process of colonization and offered health care workers some practical tools for building relationships with people from colonized communities. She reflected on historical events that have shaped current realities for both indigenous and non-indigenous persons, and offered insights on how we can move forward together from the socializations we have all received. This event is made possible each year through the William F. Mitchell Endowment Fund.

With the recent passing of federal legislation related to Medical Assistance in Dying, Ethics Services, in collaboration with Practitioner Staff Affairs and Saskatoon Health Region Legal Counsel, put forward a Medical Assistance in Dying Policy that was approved by the Saskatoon Regional Health Authority and the St. Paul's Hospital Board. The policy is being used to guide staff decision making on matters related to medical assistance in dying, and to balance the right of patients

seeking medical assistance to die against the right of health care professionals to have a conscientious objection.

This past year, Ethics Services was very active in dispensing educational information to patients, families, staff and students. Topics included advance care directives, resuscitation, medical assistance in dying, ethical care for people with addictions, ethical care of elderly people in the acute care environment, ethical decision making, Introduction to Ethics and numerous other Ethics Facilitator course education sessions.

Laboratory Medicine and Pathology Services

St. Paul's Hospital performs testing and specimen analysis for Saskatoon Health Region patients and external referrals in the areas of Anatomical Pathology, Clinical Biochemistry, Clinical Hematology and Transfusion Medicine.

This year, over 4,000 tests were completed per day at our High Volume Laboratory at St. Paul's. By maintaining a steady focus on improvement, the lab consistently provides a high level of accurate and quality testing. This year marked the tenth anniversary of a pilot project to implement "Lean/Six Sigma" theory, which ensures that each day the lab uses tools (e.g., visibility boards, staff huddles, and other indicators) to improve waste reduction, reduce variation and maintain a clean work environment.

St. Paul's Hospital also manages Laboratory Medicine and Pathology Services across the region, and has been working to ensure the laboratory system is functioning at or above all accreditation standards in the delivery of safe and efficient care. This year, the laboratory system achieved full accreditation.

The laboratory manages approximately 600,000 specimens in various forms throughout the pathology process. At the Saskatoon City Hospital core laboratory the Pathology division has been undergoing transformational change, including investigation and installment of a bar-coded tracking system process to help ensure that patient samples can be located instantly, and reduce error. Laboratory Medicine also completed a number of major projects that focus on patient flow and safety, including expanding services at the Mark Baltzan HLA Laboratory at St. Paul's Hospital in order to provide post-transplant screening and added testing to support the HIV population.

Emergency Services and Saskatchewan Air Ambulance

St. Paul's Hospital supports Emergency Services throughout the entire Saskatoon Health Region. The Emergency Department is a demanding environment in which to work. Emergency Department physicians, nurses and support staff strive to provide expert care in a compassionate manner that meets the physical, spiritual and cultural needs of patients who require urgent care.

St. Paul's collaborates with Saskatchewan Air Ambulance, a critical care transport entity that serves the entire province and beyond. Over 1,400 patients were transported via Saskatchewan Air Ambulance this past year, two-thirds of whom required urgent and/or critical care. Emergency Department staff provides medical assistance following handover of transported patients. Our dedicated team reviews every Air Ambulance trip to ensure that exceptional patient care is provided during transport.

Some highlights this year included the implementation of an electronic health record system in all three Saskatoon hospital Emergency Departments.

Emergency Services also implemented a change in the triage process at Royal University Hospital that reduces wait times for patients to be seen by a triage nurse. St. Paul's Hospital has been identified as the next site for rollout of this new process (initial work, including data collection, has already begun). We hope to have fully implemented changes within the coming year.

Diagnostic Imaging and Nuclear Medicine

This program area within St. Paul's Hospital has come a long way since the Grey Nuns took the Hospital's first X-ray in 1913! X-rays play an important role in both diagnosing and preventing the spread of disease. Today, highly skilled Diagnostic Imaging and Nuclear Medicine staff and physicians use specialized equipment to generate detailed images that enable them to identify, analyze, diagnose and treat a wide range of medical conditions across the region.

This year at St. Paul's, we celebrated the grand opening of the David and Karen Holst Family Foundation SPECT-CT Suite. The new SPECT-CT scanner allows doctors to pinpoint and assess the location and severity of a suspected illness in just one patient visit. A first for Saskatoon, the SPECT-CT will benefit patients suffering from cancers, brain tumours, diabetic complications and other conditions. Through generous donations, we were also able to purchase a new Philips EPIQ Ultrasound unit for our Angiography/Interventional suite. This technology allows us to use a variety of top-notch, state-of-the-art imaging methods to obtain multiple views for the best possible imaging to guide active procedures.

Chronic Disease Management

St. Paul's Hospital demonstrates its core value of compassionate care through the LiveWell Chronic Disease Management Program. A team of experts in this area works with patients and their families as they adjust to living with chronic

disease. Programs and services include individual and group education, exercise sessions, individual clinical counselling, multidisciplinary clinics and self-management workshops.

Chronic Disease Management is improving the lives of people living with diabetes by standardizing the way in which diabetes is treated across the Health Region through an Insulin Task Force. Diabetes patients who require insulin therapy while in hospital are now using the same therapy regimen as a patient would practice in his or her own home; this allows for a seamless transition for patients and residents who may require treatment in hospital. These best practices are now being used in the Region's acute care facilities and in 30 long-term care homes. The Insulin Task Force is the first group to standardize diabetes management in the province, and is now sharing its work with other health regions throughout the province. The Task Force is also working to standardize treatment for patients with diabetic ketoacidosis, a serious complication of diabetes.

Chronic Disease Management also works in partnership with other groups and programs to spread messages of health and well-being throughout the community. For example, Aim 4 Health offers a friendly and supportive environment for First Nations and Métis people, as well as newcomers to Canada, who either may be at risk of developing diabetes or already have diabetes and would like extra support in managing their own care. The program provides individualized and community-based diabetes education and outreach programming in partnership with the Westside Community Clinic, White Buffalo Youth Lodge (WBYL), Community Peer Leader Program, Saskatoon Food Bank and Learning Centre and Affinity Credit Union.

In recognition of St. Paul's Hospital's commitment to reconciliation, work is underway to incorporate traditional Indigenous world views, cultural practices and knowledge as a regular part of programming, and to improve health equity outcomes by addressing the issue of food insecurity among program participants.

Kidney Health

St. Paul's Hospital is a provincial leader in the treatment of renal (kidney) diseases, providing specialized services within Saskatoon Health Region as well as to Northern communities.

Saskatchewan's first kidney dialysis was performed at St. Paul's Hospital in May 1960. Since then, thousands of patients with kidney disease have received kidney health services. Hemodialysis services are provided at the Hospital, in a community setting at the Cameco Community Renal Health Centre in Saskatoon and in satellite units in Lloydminster, North Battleford, Prince Albert and Tisdale. Kidney Health Services also provides training and support for patients who perform their own dialysis via peritoneal dialysis (a home-based treatment that patients can do on their own) and for those who wish to receive hemodialysis at home through the Home Based Therapies Program.

The Kidney Health Community Program is working to prevent kidney disease by promoting healthy living to people in Saskatoon and surrounding communities as well as Northern Saskatchewan. This year, the program hosted a number of community engagement forums called "Nisohkamâtowak" (Helping Each Other) at Wanuskewin Heritage Park and in Northern communities. These sessions are aimed toward making a positive, healthy difference in the lives of those in the communities we serve. Nisohkamâtowak also seeks to place the lived experiences of First Nations and Métis patients and families at the heart of our programs, so that services reflect and accommodate appropriate cultural values and beliefs.

The Kidney Health Program has an active, engaged Patient and Family Advisory Council with projects this year focussing on advanced care planning, transitions in care and mentoring. Other initiatives were undertaken this past year to support non-surgical catheter placement, ensure proper access assessment and care, improve clinic flow and support engagement of patients and families.

Provincial Transplant Services

St. Paul's Hospital has been home to the Saskatchewan Transplant Program since 1989. During that time, hundreds of corneas and kidneys have been transplanted under our roof. The program also supports patients who require or have received heart, lung, combined kidney-pancreas or liver transplants.

The Transplant Program continues to engage stakeholders across many sectors to support organ and tissue donation, as well as patients being assessed for or actively awaiting transplant or those who have received a transplant.

The *Offer Hope* campaign encourages people to consider organ donation and features personal stories from both donors and recipients of organs.

Mental Health and Addictions

Mental Health and Addiction Services provides inpatient psychiatric care, detox/residential addictions treatment and outpatient clinical services to individuals and their families living with mental health and/or addiction issues.

We work closely with community partners to develop new models and approaches to care so that we can support stronger relationships with clients and partners, and make a positive difference in the community.

This year, the Connecting to Care pilot project was created to assist clients in Saskatoon who utilize our hospital services frequently. By improving the quality of life of those receiving services – including improving the way patients are managed and providing better nursing, psychology and cultural supports – we were able to reduce hospital visits.

With the onset of the fentanyl crisis this past year, Mental Health and Addiction Services conducted a provincial pilot for a Naloxone Program. This program provides naloxone kits as well as training

on how to use them, to those at risk of opioid overdose. The program has expanded to train organizations who routinely provide care to those at risk of opioid overdose, and through a partnership established with the Saskatoon Fire Department, that department is now equipped with naloxone. The success of this pilot project at St. Paul's Hospital has led to an expansion of the project across the Saskatoon Health Region.

We continue to collaborate with community partners to develop and deliver a solid continuum of care for the most vulnerable in our community. These organizations include The Lighthouse Supported Living, Sanctum, Saskatoon Crisis Intervention Services, Westside Community Clinic, Saskatoon Housing Initiatives Partnership (Saskatoon Plan to End Homelessness) and others.

New Patient and Family Advisory Councils (PFACs) were introduced this year for adult addictions as well as child and youth mental health and addictions. We are co-leading an HIV Council with Saskatoon Health Region Population and Public Health. At the Dubé Centre, the existing council was repurposed to address all adult inpatient and outpatient mental health services. We are deeply grateful to all of the advisors who are providing excellent service improvement ideas.

We also established an Adult Addictions Day Program provincial working group to address the high incidence of crystal methamphetamine use, and inpatient flow at the Dubé Centre was significantly improved. The Breaking the Barrier initiative, a collaboration with numerous community partners, is working to reduce the stigma associated with mental health and addictions.

Palliative Care and Hospice Services

Palliative Care Services has been providing compassionate end-of-life

treatment and care to patients and their families for over a quarter century. The ultimate goal of a palliative approach is to ease the experience for people living with life-threatening illnesses, or nearing the end of their life. Engagement of families in the provision of care and support is a core part of this work.

Each year, Palliative Care invites the community to share, in two special ways, in the grieving process of friends and family who have lost a loved one. The Memory Tree program provides a way for people to seek peace through expression of their emotions that might appear to be out of step with the more usual holiday spirit. Anyone who wishes may fill out a holiday card in honour of a loved one and leave it on the Memory Tree, which is on display at Market Mall from November until Boxing Day. Friends and family members can also participate in the Walk of Memories, an annual walk organized by Palliative Care Services to remember loved ones and support the department.

St. Paul's Hospital has a 12-bed Palliative Care Unit and leads Palliative Care Services across the region. There is supplementary in-home care available for patients and families, as well as a comprehensive long-term care system. However, at present, the critical missing piece within the continuum of care for palliative care patients and families in Saskatoon is hospice care. To this end, St. Paul's Hospital has been planning the development of Saskatoon's first residential palliative care hospice. We look forward to continued planning in the coming year to develop specific, compassionate clinical support for patients and families facing end of life.

The relationships we have nurtured with these individuals and our relationship with the community provide us with motivation to prudently manage the giving and receiving of funds on behalf of the Hospital. We feel truly blessed to do this work each and every day.

This year, our Foundation made an effort to reach out further into our community to spread the word of our Hospital's history, our Foundation and how we are working together to achieve our Hospital's vision of "A community of health, hope and compassion for all." Through monthly chats with members of various service clubs, including Catholic Women's League and Knights of Columbus groups in Saskatoon, we shared our Hospital's success stories, our goals for the future and our unwavering commitment to holistic, compassionate health care that extends into our community.

We were thrilled with the success of our fund raising for the Nītisānak Navigator pilot project this year. Through the Cameco Cares Concert Series, our community helped us raise funds that will be used to integrate an individual called the "Nītisānak Navigator" into our emergency rooms to provide individualized patient support and develop specialized care plans based on the unique needs of Indigenous patients, their families and the community.

We were excited to introduce a new email donor publication called Kindred Spirit. Kindred Spirit is issued twice yearly and shares St. Paul's Hospital stories of interest to our donors.

In 2017, we will be fund raising for a number of exciting projects that will have meaningful impacts on patient care. Some of these projects include a 2-D echo cardiac machine for Heart Health, an angiojet for Medical Imaging, sleeper chairs throughout the Hospital and microscope equipment for the Mosaic Laboratory.

We also are raising \$425,000 for equipment for a new Ear, Nose and Throat Clinic, which will integrate the Healing Arts into the daily work of the clinic – a first in Canada!

Highlights: Your Gifts in Action

Celebrating Advancements in Operating Theatre Technology and Training

As an acute care teaching facility that performs over 10,000 surgical procedures each year, our operating theatres are crucial to patient care and to the education of our surgeons, physicians, nurses and staff. The Foundation is pleased to report that, thanks to the wonderful generosity of our donors, \$4.9 million was raised to provide St. Paul's with the most advanced Hospital operating theatres in Saskatchewan.

We celebrated this achievement on October 4, 2016, at our Behind the Curtain event, which recognized donors and showcased some of the ways donor gifts are helping to enhance change and to impact patients' lives. All eight of our operating theatres have been upgraded, and six of those theatres are now Advanced Integrated Suites equipped with state-of-the-art technologies that meet the needs of new and rapidly evolving surgical care technologies.

The theatres are now operating more efficiently, resulting in reduced surgical wait times and improved patient care, and are an excellent teaching resource as well. Funds were raised through donor support that included Joe Remai, the many donors who responded to a letter from Operating Room Manager Alicia Oucharek Mantyka, Mistletoe Ball sponsors, guests and those who purchased Hospital Home Lottery tickets.

Transforming Patient Care with New Technologies and Precision Imaging

The Hospital's new medical imaging SPECT-CT Suite was officially opened at our Behind the Curtain event. At the event, the Suite was officially named the David and Karen Holst Family Foundation SPECT-CT Suite in recognition of the family's major gift to St. Paul's Hospital Foundation. Jack and Shirley Brodsky, Joe Remai

and the Dakota Dunes Community Development Corporation also donated substantial gifts to support the new suite. The SPECT-CT uses state-of-the-art technology that combines a nuclear medicine gamma camera with the latest diagnostic CT technology to provide advanced imaging. With the new SPECT-CT technology, St. Paul's Hospital physicians and specialists now have access to the most advanced technologies available for diagnosing, monitoring and treating multiple medical conditions including various forms of cancer and diabetic infections, using minimally invasive techniques that improve the patient experience.

Improving Access to Knowledge

This year, the Foundation completed raising funds to upgrade our Medical Library and to create a new Patient and Family Resource Centre. These upgrades will ensure that medical staff have easy access to the most current medical research, and will provide useful resources for patients and families as well. We are pleased to report that construction of the new centre has begun and in the coming year, we will be inviting our donors to gather to celebrate the opening of this valuable resource in our Hospital.

Other Foundation Fund Raising Projects

Nitisānak Navigator Pilot Project: The Foundation completed fund raising for a number of other important projects this year, including the Nitisānak Navigator pilot project. In the coming year, "The Navigator," an individual well versed in both First Nations and Métis culture as well as our medical system, will be stationed in the St. Paul's Hospital Emergency Room. The Navigator will support the work of First Nations and Métis Health staff already working there and will provide additional support to patients who have unique needs, and in cases where there may be language barriers and cultural differences. They will develop specialized care plans based on

these needs for the patient, the family and the community. Funds were raised through the 2016 Cameco Cares Concert Series.

Healing Arts: Each year the Foundation raises money for the Mission Office's Healing Arts Program with a maximum grant of \$140,000 annually. Additional program funds were provided this year by Dakota Dunes Community Development Corporation and numerous other donors.

Spiritual Care: As stewards for the Grey Nuns Legacy Endowment, the Foundation also provides \$100,000 annually to Spiritual Care at St. Paul's.

Leslie and Irene Dubé Urology Centre for Health: Funds were raised to support post-prostatectomy programming and patient education at the annual Urology Symposium. Donors also provided monies to support purchases of cystoscopy equipment including a Mini C-Arm X-Ray Scanner, two Radiolucent Operating Theatre Tables and two MDS Mobile Display Systems. These funds were raised through individual donations and fund raising events including: Rock 102's Caged for the Cure, the Driving Fore Prostate Golf Classic 2016 and the Gormley Gathering 2016.

Test pilot of equipment used for Irreversible Electroporation (trademark: Nanoknife) procedures: We allocated funds to test this minimally invasive procedure that uses electricity to eradicate cancerous tumours. St. Paul's Hospital is home to one of only two such machines currently available in Canada.

Staxi Chairs: Funds were raised for 11 new Staxi chairs currently used to transport patients throughout the Hospital. These simple and easy-to-use chairs often can be used in place of more expensive standard wheelchairs and were funded by the people of Saskatoon through the Legion's Saskatoon Poppy Fund. The Saskatoon Poppy Trustees thank all donors for their support in helping countless patients move around the Hospital.
