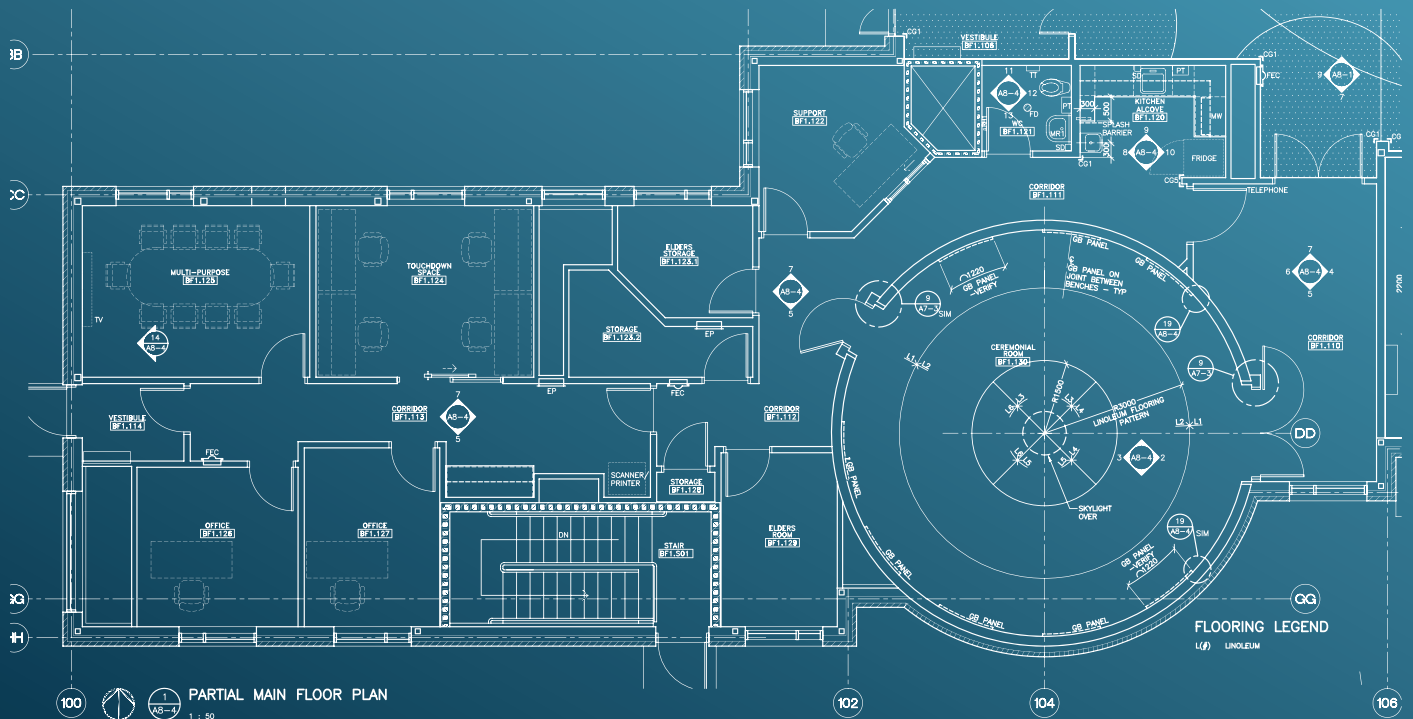

The physicians, healthcare workers, staff and volunteers at St. Paul's Hospital deliver comprehensive and compassionate health care to the people of Saskatoon and Saskatchewan. In addition to caring for the physical needs of our patients, we also commit to addressing their holistic needs by offering care for the mind and soul. We are driven by our values, which call us to serve the needs of the most vulnerable, to witness the humanity of those whom we serve and to uphold their dignity while providing the highest quality of holistic care.

St. Paul's Hospital is one of thirteen healthcare facilities in Saskatchewan governed by Emmanuel Health, and operates in partnership with the Saskatchewan Health Authority. St. Paul's Hospital is responsible for the governance of the following programs: Chronic Disease Management, Diagnostic Imaging and Nuclear Medicine, Emergency and Air Ambulance Services, End-of-Life Care, Ethics Services, Kidney Health Services, Laboratory Medicine, Mental Health and Addiction Services and Spiritual

Care. The Hospital is also home to the Leslie and Irene Dubé Urology Centre of Health and the Saskatchewan Transplant Program.

In 2021, St. Paul's Hospital expanded its campus with the establishment of the Hospice at Glengarda. This facility became the thirteenth facility governed by Emmanuel Health, with operations managed by fellow Emmanuel Health affiliate Samaritan Place. St. Paul's Hospital Foundation is responsible for all fundraising initiatives in support of the Hospice.

Hospital Highlights

Mission Office

The Mission Office oversees and supports the programming for Spiritual Care, Spiritual Care Education and the Healing Arts, as well as chairing the work of the Schwartz Rounds and St. Paul's Hospital Truth and Reconciliation Committee.

The Mission Office aims to help staff see the connections between their work and the mission, vision and values of St. Paul's Hospital.

The Mission Office coordinates events, including our annual Mission Week in October, Project Christmas Angel in December, a Hot Chocolate Cart on "Blue Monday" in January and Community Day in May. When those who come through our doors feel welcomed, especially those who are most in need, we are living the mission of St. Paul's Hospital and continuing the compassionate legacy of the Grey Nuns.

Healing Arts

Our Healing Arts Team enhances and supports holistic care in our Hospital, creating opportunities where patients, families, community and staff can connect and engage in the creative arts to support health and well-being.

This year, Artist-in-Residence Marlessa Wesolowski collaborated with the College of Medicine and several cohorts from the Practical Nursing Program at SaskPoly Tech to provide students with unique educational opportunities, including gaining deeper understandings of the mission of the Hospital, our areas of focus, the physiological impacts that arts can have in caring for the whole person, and how to integrate the Healing Arts into patient care. They also had an opportunity to participate in experiential learning by creating a collective art project. Marlessa also chaired the Green Thumb Committee, which included working alongside SPH Cultural Advisor Vernon Linklater and Elder George Laliberte to create and name the Meupikihitowin Garden, which means "a good place for growing together (knowledge & health)" in Cree.

Adjacent to the cafeteria patio space, the garden contains over one hundred native plants and a traditional Indigenous Medicine Circle, and was planted in collaboration with the Canadian Wildlife Federation. Marlessa continued to build relationships in our community, and collaborated with Common Weal Community Arts, SCYAP and Prairie Harm Reduction Drop-In.

In 2023, the SPH Music Therapy Team offered a monthly "Take 5: Music on the 5th Floor" group, where patients, caregivers and staff joined in music-making together. They hosted a "Take 5" Holiday Party in December that offered music bingo, holiday trivia, hot chocolate and prizes for winners. Music Therapist Lisa Wutch also created the "The 7th Floor Music Club", which created space for patients and caregivers to gather at the end of the hallway to listen, sing, play instruments, request meaningful songs, socialize and share their hospital experiences.

Music Bingo continued to be a big hit with patients receiving hemodialysis treatment. Bingos were held in May, September and December; more than 150 patients participated in each event with the chance to win wonderful prizes from local businesses.

Spiritual Care and Spiritual Care Education

Spiritual Care offers opportunities for patients, loved ones and staff to find meaning, comfort and spiritual connection in the in the manner most valuable to them. The Spiritual Care Department also connects patients and their families with a faith group representative of their choice whenever requested, and coordinates milestone events such as weddings, baptisms and memorial services. The Department also facilitates educational events for Hospital staff and learning opportunities for medical students.

In 2023, the Spiritual Care Team was very grateful to partner with the Healing Arts Team to reinstate the Celebration of Life memorial services after the easing of pandemic precautions. These services are held four times each year, and invite families to honour their loved ones who have passed away at St. Paul's Hospital. The Team also coordinated activities for patients and staff during Spiritual Care Week in October 2023, highlighting the evolving character, professionalism and training of those who work in this field.

Spiritual care providers are trained through a program called CPE (Clinical Psychospiritual Education) that has been offered at St. Paul's for more than thirty years, and is supported by the Foundation's Grey Nuns Legacy Fund. This training program supports the development of quality Spiritual Care Providers within faith communities and the broader community. The Spiritual Care staff at St. Paul's developed their skills through CPE. This year, Spiritual Care Educator Julie Bergen worked with a new CPE Supervisor, Erika Mills, at Santa Maria Senior Citizen's Home in Regina. This valuable opportunity will extend the reach of CPE in Saskatchewan, ensuring that more students will be able to access this foundational training.

Ethics

Ethics Services plays a large role in providing staff, patients and loved ones with the support they need when dealing with challenging health care decisions.

This support is provided through individual consultations, education programs and presentations for wider audiences; for instance, Director of Ethics Dr. Mary Heilman presented on "Advocating for Palliative Care in Challenging Situations" in the February 2024 SHA Ethics Exchange.

Community Support Helps Healthcare Workers Address Bias

The W.F. Mitchell Bioethics Seminar is a keystone annual event made possible through an endowment bequeathed to St. Paul's Hospital Foundation in memory of the late William F. Mitchell, a local business owner with a strong sense of ethics in both business and community.

This year, the Emmanuel Health Ethics Committee invited Sean Polreis, Teaching and Learning Specialist for Faculty Development in the College of Medicine at the U of S, to give a two-part presentation titled "Unconscious Bias: Self-Improvement Through Awareness" and "Unconscious Bias: Implications for Health Care Delivery." His reflections on these topics, delivered on November 6th and 7th, 2023 in Pylpchuk Hall at SPH, were offered both in-person and online, and served to develop an understanding of what constitutes bias, as well as to raise individual awareness of personal bias, discuss the ways that bias can influence patient care and talk about how to mitigate its negative impacts as we serve all those in our community.

In 2023, Ethics Services supported SPH with 18 education sessions and 55 patient and family consultations.



Emergency Services

St. Paul's Hospital is home to the second-largest Emergency Department in Saskatoon. The Department has long been a point of support for both our city and our province, and we are proud to have strong partnerships with our community. In 2023, we formed a new partnership with Saskatoon Tribal Council and the Sawēiyhtotān Project Outreach group to create a supportive presence in our waiting room every night. They offer compassionate care to those in the community struggling with food and housing insecurities through advocacy, support and finding safe places to go once discharged from the Hospital.

The Emergency Department is home to the Rapid Access Addiction Medicine (RAAM) Clinic and the Emergency Department Addiction Counsellors (EDAC) Team. These invaluable resources provide opportunities for positive intervention to patients living with addictions. Our strong partnerships have increased positive

outcomes for each person who presents to the Emergency Department, and have allowed us to better serve our patients.

This past year was a very busy one for Emergency, which saw an average of 114.8 patients per day visit the Department, as compared to 101.4 patients registered per day in 2022. The Department also saw an increase in acutely ill patients needing more intensive care. Our staffing complement was increased when ER hours were expanded for Unit Assistant, Continuing Care Assistant, Registered Nurse, Clinical Nurse Educator, and Nurse Clinician positions. Our department holds continuing education in high regard, and was pleased when many of our Registered Nurses participated in professional development opportunities to better their professional practice.

In 2023, we had the opportunity to bring new chairs into our waiting room. As well,

new display cases will soon exhibit art supplied by children who attend the daycare located within the Hospital. We were also excited to complete a much-anticipated renovation to our trauma area.

Donor Support Advances Critical Care

With help from **St. Paul's Hospital Foundation Draws**, the ER was able to purchase a vein finder, treatment chairs and privacy screens for the triage area, and portable vital signs monitors to facilitate better patient comfort and experiences. **St. Paul's Hospital Foundation's Cold Hands, Warm Hearts** fundraising campaign enabled the ER and other units to distribute warm toques, mitts and hand warmers to hundreds of community members during bitterly cold weather. We are immensely grateful to our donors for supporting this program, and for believing in our Hospital's mission to serve the needs of the most vulnerable in our community.

Diagnostic Imaging and Nuclear Medicine

Diagnostic Imaging and Nuclear Medicine plays an integral role both in diagnosing and in treating the spread of disease.

Highly specialized staff use innovative equipment to help identify, analyze, diagnose and treat a wide range of medical conditions. Diagnostic Imaging staff support patients and their loved ones, as well as the healthcare team as a whole, often working collaboratively with other teams at the Hospital. We fully embrace patient and family-centered care as a fundamental value of the Department, serving the needs of patients while also involving family and other supporters whenever appropriate.

Further, Diagnostic Imaging staff have been building capacity to support our co-workers by attending the Mental Health First Aid course offered by the Mental Health Commission of Canada. This course provides attendees with tools to recognize and respond to mental health crises that could be exhibited by patients and fellow staff members in the workplace, and equips healthcare workers to address the well-being of their peers and themselves in addition to the well-being of patients.

New Ultrasound Technology Makes Prostate Biopsy Safer

This year, under the leadership of Radiologist Dr. Jeff Bird and Urologist Dr. Kunal Jana, we were happy to introduce the new Aplio Ultrasound Machine to the Unit. This acquisition was made possible through the phenomenal

generosity of Associated Radiologists LLP and Daphne Arnason & Leo Bourassa. For patients requiring prostate biopsies, the machine performs trans-perineal procedures that are extremely safe, highly efficient and minimally invasive. When a patient arrives for their biopsy, they have often already had an MRI completed that may have identified lesions that cannot be seen on a traditional ultrasound. The Fusion technology within the Aplio Ultrasound Machine allows radiologists to import MRI information and fuse it with what they see through the ultrasound in real time, increasing diagnostic accuracy and further improving patient outcomes.

Donors Upgrade Efficiency

Diagnostic imaging is a constantly advancing field, and updating equipment as that technology progresses ensures that patients will be given the most accurate diagnoses and best possible treatment options during their hospital visit.

With funding made possible by donors' generosity, the Department was excited to finalize state-of-the-art upgrades to our MRI Scanner, reducing exam duration and significantly increasing the quality of the scans, positively impacting our patients.

With St. Paul's Hospital having the only Lithotripsy program in the province, it is vital that we keep pace with new technology and development. We are excited about the installation of a new lithotripter, which allows us to continue to offer a less invasive method of treating kidney, bladder, and ureteric stones to the patients of Saskatchewan. We are deeply grateful to donors Leslie and Irene Dubé, whose leadership and philanthropy brought the first lithotripter to the province in 1997, then upgraded that technology at our Hospital in the Spring of 2024.

Mental Health and Addiction Services

Mental Health and Addiction Services (MHAS) provides a range of services for clients of all ages who face moderate to severe issues involving mental health and addictions.

The Rapid Access Addiction Medicine (RAAM) Clinic located at St. Paul's Hospital has been operational since February 2020. To date, the RAAM team has supported 10,789 client visits, demonstrating that there is great need for swift and barrier-free access to medical and psychological supports for those who use substances. As well, the Clinic welcomed Dr. Isaac Cheveldae, a contracted psychiatrist and a tremendous addition to our community addictions teams.

On August 31, 2023, a number of teams within MHAS, including the **Opioid Assisted Recovery Services team (OARS)**, **RAAM**, the **Overdose Outreach Team**, and our partners from the Saskatoon Fire Department, participated in an event to recognize International Overdose Awareness Day. The event honored the lives of those lost to overdose. It also served to support the loved ones they have left behind, to raise awareness and provide education for reducing stigma, and to recognize the ongoing efforts made to reduce overdoses in our community. The staff from MHAS provided take-home Naloxone training and kits, as well as resources regarding opioids, overdoses and sources of support. The event was open to all, and was very well attended by community members. The teams plan to participate in a similar

event alongside community partners in the Summer of 2024. We are optimistic about the new Drug Alert System implemented by the Government of Saskatchewan, which will allow the Ministry of Health to better coordinate the issuance of drug alerts while partnering with organizations who monitor the toxicity of illicit drugs across the province. This is an important investment and resource for bringing safety to our clients and community.

The Brief and Social Detox Unit implemented a new staffing model in early 2023, increasing nursing staff to ensure services are available 24 hours a day, 7 days a week. This has positively impacted client care, and expanded services that can be delivered within the program. With this new staffing model, we hope to reduce client transfers to the Emergency Department and offer enhanced medical supports for those who require detox from substance use. We have seen record requests for service, with a demand that exceeds capacity of these units. The team works tirelessly to provide care to those that request this service.

Generosity Powers Education

St. Paul's Hospital Foundation was very pleased to support Pharmacist Amy Wiebe as she participated in the British Columbia Centre on Substance Use Addiction Pharmacy Fellowship Program. Amy is the first pharmacist from Saskatchewan to participate in this program, which trains

highly skilled pharmacists in ensuring the safe and effective use of medications, optimizing treatment outcomes and assisting in the development of protocols that focus on best serving patients living with addictions. Amy is an accomplished professional who has received numerous awards for leading innovative projects within our province. In addition to more than fifteen years of clinical experience, policy development, leadership and educational programming, including important work at St. Paul's Hospital, Amy is a founding member and clinician contributor to the USask Chronic Pain Clinic, a pharmacist-led clinic located at the University of Saskatchewan. SPH Foundation is glad to support this educational opportunity and anticipates the positive health outcomes that Amy's increased education will bring to patients and their loved ones in our community.

Laboratory Medicine

St. Paul's Hospital Laboratory provides services in the departments of Anatomical Pathology, Hematology, Clinical Biochemistry, Transfusion Medicine, Immunodiagnostics, and Histocompatibility and Immunogenetics. The Laboratory is also a transportation hub for the testing and referral of specimens both from within Saskatoon and from rural centers and communities.

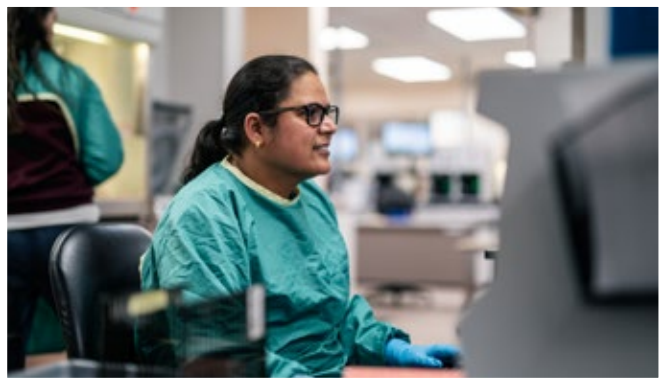
In the past year, the **Marc Baltzan Histocompatibility and Immunogenetics Laboratory** at St. Paul's Hospital has continued to make noteworthy contributions to the field of organ transplantation. We extend our sincere gratitude to Canadian Blood Services for acknowledging our Lab's significant role in the "1000 Kidney Paired Donation" program. Our commitment to public awareness was evident as we actively participated in the "Walk and Talk" event organized by the Move For Life Foundation, raising an impressive \$7,145 to support organ donation education.

Our Lab is pleased to have extended our services to the Saskatchewan Transplant Program and the Saskatchewan Cancer Agency. The Saskatchewan Transplant Program set a new record, with 47 patients receiving transplants this past year; the Saskatchewan Cancer Agency also facilitated 30 stem cell transplants during that time. We are proud to announce the successful completion of an American Society for Histocompatibility and Immunogenetics inspection on May 16th, achieving compliance with all required standards and earning a renewed two-year term of full accreditation. This accomplishment reaffirms our commitment to maintaining the highest levels of professionalism and expertise in our field. Our presence at the annual international American Society for Histocompatibility and Immunogenetics conference in San Antonio, Texas was marked by three talks and two presentations, underscoring our laboratory's reputation on a global scale.

These achievements reflect our unwavering dedication to advancing health care and saving lives through cutting-edge research and clinical excellence.

Donor Support Brings Innovation

Our phenomenally generous donor community has enabled us to provide better patient care with Cellavision, the digital imaging component of Complete Blood Count (CBC) testing. CBC is one of the most common tests requested by physicians. The high-volume Hematology lab at SPH may analyze upward of 1000 CBC tests each day, receiving samples from rural areas as well as from Saskatoon. These tests, depending on results, can lead patients to have further samples sent to the Hematology Lab at SPH. Bringing this state-of-the-art technology to the Lab will significantly reduce turnaround times, allowing test results that previously required 1-4 days for completion to now be finished within hours and quickly communicated to patients' physicians. This means that patients will have their results sooner, whether they live in the city or in a rural setting, saving invaluable time and providing far-reaching positive impacts on health outcomes for those in our province.

End-of-Life Care

St. Paul's Hospital has been leading end-of-life care in Saskatoon since the opening of the city's first Palliative Care Unit at the Hospital in 1990. For as long as we have held Palliative Care as a leadership area,

we have been providing compassionate care to patients and their loved ones, serving them in a manner that addresses the social, emotional, physical, cognitive and spiritual needs of people receiving care at end of life.

397 patients journeyed through the Palliative Care Unit this year



St. Paul's Hospital's Palliative Care Unit

Palliative Care Services at St. Paul's Hospital works as a holistic team of specialists to provide support to patients and their loved ones as they receive end-of-life care.

Our holistic care approach endeavors to address the needs of the patient while honoring the whole person, rather than only their diagnosis. We partner with other units within our Hospital to serve patients who face life-limiting illness, and work alongside the Hospice at Glengarda and other palliative care services in the community.

In the past year, we had the opportunity to build on the welcoming environment in our Unit and plan for the future by refreshing patient rooms with significant support from St. Paul's Hospital Foundation. We trialed new beds and settled on a top-of-the-line model for each patient's room. The Art Cart continues to travel the Unit, offering patients the opportunity to select artwork of their choice for their rooms. We also added new sleep beds and furniture for family use, a "tickle trunk" for children who come to visit loved ones, and added a fresh coat of paint to our patient rooms and our hallways. As well, the addition of new storage, renovation of the family kitchen and

revitalization of our volunteer program are in the works. These family and community spaces are integral to those who visit our Unit, and allow for loved ones to spend quality time with patients as well as with one another. This past year, we even hosted a wedding in our Family Room.

We continue to offer holistic programming to patients and families, with full-time Music Therapy coverage now offered on the Unit. Our Palliative Care music therapists do wonderful and important work, facilitating legacy projects such as producing heartbeat recordings of patients that can be overlaid with a patient's favourite song or recording of choice. This year, the Healing Arts Team collaborated to extend the invitation for the Take 5 Music Club to the families of patients staying in Palliative Care. Family members also can access the mobile art workshop when it is offered on the 5th floor common area by our Artist-in-Residence.

Your Support Provides Comfort in our Community

The Palliative Care Unit is deeply thankful for community support that has not only

contributed to our Unit renovations, but also allowed us to purchase items that bring home-like touches to our space such as a fireplace and fresh décor, games and puzzles for our Family Room, a Memory Tree at Christmas, and mini-fridges for each patient's room. Additionally, we were able to enhance the safety of supported patient transfers with the purchase of a "Sara Steady" lift. Donors' generosity has also ensured the continuation of our **Comfort Care Cart**, with food items and beverages served to families by volunteers.

Community donations created the **Hospice and Palliative Care Education Fund** to support training and education for end-of-life caregivers, and advanced important endowments to support holistic palliative care staffing and programming at St. Paul's Hospital, the Hospice at Glengarda, and in the surrounding community. In 2023, several staff attended the "Physical and Emotional Suffering at End-of-Life" conference in Saskatoon, as well as LEAP™ core training, which builds essential competencies to provide a palliative care approach.

Hospice at Glengarda

The Hospice at Glengarda provides patient-centered, responsive end-of-life care and support, offering each patient and their loved ones the opportunity to live life fully throughout the time that they are with us. We take pride in exceptional teamwork and use an interdisciplinary approach that focuses on holistic patient-centered care.

This year, we welcomed Robin Stahl into the Site Lead Position, and Kristin Hubic as Manager of Patient and Family Relations. We worked to further our collaboration with Community and Acute Care to ensure patients are referred to Glengarda without delay, and receive the support they need at all steps of their palliative journey. We also continued to develop and strengthen our relationships with the community by providing educational opportunities and welcoming nursing students to complete their final practicums at our Hospice. The presence of nursing students at Glengarda has improved the students' awareness of the important work we do, supported inclusion of the palliative care and end-of-life care approaches into nursing curricula, and created learning opportunities for our staff as they learn about new advances in health care from the students.

We were pleased to host Accreditation Canada for completion of a Supplementary Survey of the Hospice in October 2023. We successfully met each standard,

demonstrating our commitment to providing safe, high-quality health services. Community donations through St. Paul's Hospital Foundation supported Hospice staff through the Palliative Care Education Fund, which helps staff access training and education such as the LEAP™ Core Training offered in 2023.

Thanks to the continued and generous support of our community through SPH Foundation, our **Holistic Care Team** provides individual programming for patients and their families, offering whatever patients might wish for during their time at the Hospice. Date nights, movie nights in the Multi-Faith Room and a spa outing are just a few examples of experiences the Team facilitated this year. We have also expanded our Life Enhancement and Music Therapy offerings, including incorporating a coffee cart into the mix while offering music and interactive games to patients and their families. Through Creative Arts we have put together an Art Activity Cart, designed for patients and families to access each day and filled with supplies like paints, clay, canvas, and drawing paper. We have also improved upon our Celebration of Life events based on patient and family feedback and new ideas put forward by the Team; we will now host the events four times a year and provide crystal dragonflies to families to celebrate their loved one.

Donor Contributions Change the Landscape of End-of-Life Care

The Hospice at Glengarda was built by the generosity of donors through their support of the "Close to Home" campaign, and our donor community continues to ensure that all experiences and activities offered at the Hospice remain free of charge to patients and their loved ones. We are deeply grateful to the Knights of Columbus who began sponsoring our Hospitality Cart in 2024, ensuring that visitors have access to snacks and sundry items as needed. Our wonderful donors also ensure that flowers and food remain a part of our "Celebration of Life" events, that Christmas décor adorns the Hospice in December, and that we can purchase comfort and recreation items like a free-standing popcorn-maker for group events.

Through our community-supported Comfort Care Fund, the back entrance to the Hospice has been re-imagined. When patients arrive via ambulance, they are welcomed by a nature scene and floating candles, setting the tone for the compassionate and holistic space they are entering. The front lower patio was also completed this past summer, with a calming firepit area surrounded by thoughtfully planned landscaping and design. The new patio space includes a medicine wheel, and serves as an extension of the adjacent indoor multi-faith room.

Kidney Health Services

Kidney Health programs at St. Paul's Hospital serve the residents of Saskatoon, as well as those living in other communities across the province. St. Paul's Kidney Health Programs, Chronic Kidney Disease Clinics and Community Outreach Programs advance the early identification of kidney disease, and are committed to proactive, compassionate and accessible care that improves health outcomes for our patients.

The SPH Hemodialysis Unit and the Cameco Community Renal Health Centre located across the street from the Hospital provide life-sustaining therapy to patients requiring dialysis. These individuals and their families come to Saskatoon three to four times every week, many travelling long distances to access life-saving care. Through the Kidney Health Clinic, SPH supported 1383 patients in 2023/24 in the areas of in-hospital and home hemodialysis and peritoneal dialysis.

Our collaborative work with other departments in the Hospital is an important part of our practice. This year, we were able to make a significant positive impact on the number of patients requiring peritoneal dialysis catheter inserts by working alongside Diagnostic Imaging and our surgical partners to decrease wait times. Our Hospital's Healing Arts team is also invaluable to our patients, as kidney disease affects all aspects of a patient's health, including emotional and spiritual well-being.

Supporting Community Health

There are an estimated 117,000 people in Saskatchewan who live with chronic kidney disease. Early diagnosis and effective treatment can slow the progression of kidney disease and improve quality of life, helping patients manage their health in their home communities. In the fall of 2023, with the support of St. Paul's Hospital Foundation,

our Kidney Health Teams began the Early Screening and Detection Pilot Program, partnering with a northern community to screen community members for kidney disease and provide education about how to maintain kidney health.

Through St. Paul's Hospital Foundation, the Dialysis Unit also saw the introduction of Patient Porters, support workers who assist kidney health patients with navigating the Hospital and accessing services. Many of them arrive after having travelled from other communities, so when they step through the doors of St. Paul's, they often are tired and on their own. Our Porters have been an invaluable asset to the Unit, assisting patients in getting to their appointments and back to their homeward transportation, and helping them to feel safe and supported during an often stressful time.

The number of patients in Saskatoon and Northern Saskatchewan who require dialysis has increased by 50% percent in 10 years.

2023 Highlight: SPH Chronic Obstructive Pulmonary Disease (COPD) Program

In 2023-24, the COPD program continued to support COPD patients in their homes, at Respiratory Clinics, at the Pulmonary Rehabilitation Programs and via phone conversations. The team also continued to provide education and support to healthcare workers, as well as patients who have presented to the Emergency Department or have been admitted to acute care. Staff continue to utilize and participate in research, and work with the inter-disciplinary team to provide comprehensive care to patients with COPD and empower them to manage their health.

Primary Health and Chronic Disease Management

Primary Health and Chronic Disease Management provides pro-active and patient-centered education and support to those living with chronic disease.

The **LiveWell Diabetes Program** supports patients of all ages who have been diagnosed with pre-diabetes, types 1 and 2 diabetes and diabetes in pregnancy.

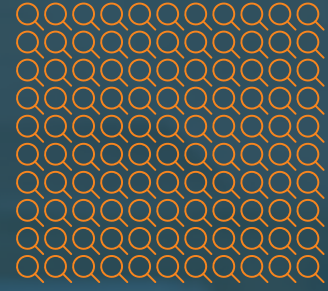
The **Pediatric Diabetes Team** offers an In-Pregnancy Clinic, an Adult Diabetes Program and Multidisciplinary Diabetes General Adult Clinics. Our **LiveWell Nutrition** individual and group programs and services are also offered to adults for prevention and management of chronic disease.

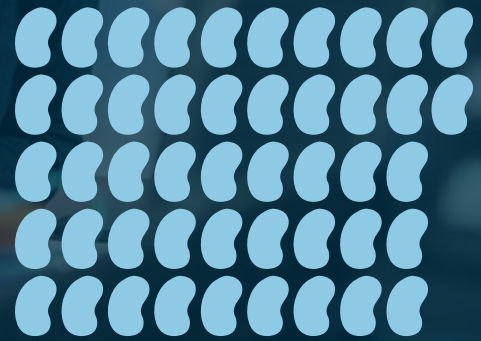

St. Pauls Hospital Foundation Highlights

BK Ultrasound and Anesthesia Ventilator Elevate Surgical Robot

In 2023, St. Paul's Hospital Foundation celebrated the 34th year of our signature event, the **Mistletoe Charity Ball and Baskets**. This year, the Mistletoe Ball and Baskets and the **Christmas Dove Letter** supported the purchase of a BK Ultrasound System and anesthesia ventilator to utilize alongside our new **da Vinci Surgical Robot**. The generous donors who responded to the Dove Letter had their kindness amplified by donor Ruby Dyck, who matched gifts received from the community up to \$100,000 with her own phenomenally generous contribution towards the BK Ultrasound.

Highly-trained surgeons at St. Paul's Hospital have been using the da Vinci Surgical Robot, "Daryl", to perform minimally invasive surgeries since November of 2022, with outstanding results. The BK Ultrasound will expand the capabilities of the robot even

further, providing real-time visualization of the targeted area during procedures and leading to even better patient outcomes.

Foundation Draws

Our Foundation Draws provide up to \$150,000 annually to support improved care and services at St. Paul's Hospital. Each year, Hospital employees submit requests to the Foundation for items to enhance patient care or Hospital programs. Thirty-four department requests were funded this past year, including wheelchairs for 6th Medicine, a work station for Health Information Services, portable stairs for Inter-Professional Practice and Physical Therapy, and a new Triage Treatment Chair that will increase patient privacy in the ER.

Love Cart

Thanks to the support of our community, Hospital Administration and Foundation employees have been wheeling a cart

loaded with snacks and sundry items throughout Hospital units, distributing them to our wonderful staff as a token of appreciation for their hard work. Staff are very appreciative of the Love Cart, and we are very grateful for the generosity that enables us to show our staff just how thankful we are for all that they do!

Creating a Better Tomorrow through a Planned Gift

A bequest in your Will costs nothing during your lifetime, but provides a lasting legacy that helps to build a bright future for health care in this province. Thank you to our **Spirit of Life** donors and to those considering leaving a bequest to our Foundation; it is your pro-active vision that supports us as we look to a future where innovation in healthcare changes and saves lives. Memorial, Honour and Tribute Gifts

Thank you to those who choose to honour their loved ones in such an impactful and compassionate way. In 2023, we received Memorial and In Honour/In Tribute Gifts totaling \$227,112. For these, we are very grateful.

Gift Shop

St. Paul’s Hospital Gift Shop is operated by our Foundation, and provides an important service to patients, staff, and visitors. Gifts, clothing, snacks, daily essentials, lottery tickets and more are available for purchase. In 2023, business significantly increased to levels not seen since before the Covid-19 pandemic, with gross revenue reaching \$191,746. All profits from the Gift Shop stay at St. Paul’s Hospital, with proceeds going toward staff professional development.


